Purpose: Funds a range of activities that deliver benefits to the arts sector and wider public, including national and international audiences.

Funding Provider: Australia Council

Amount: \$10,000 to \$100,000

Closing date: 1 October 2019

The Arts Projects program funds a range of activities that deliver benefits to the arts sector and wider public, including national and international audiences. Supported activities must last no longer than 2 years from the proposed start date.

Who can apply: They accept applications from organisations. International organisations can apply for projects that benefit practicing Australian artists or their work. Applications for funding to the Aboriginal and Torres Strait Islander panel must come from Aboriginal and Torres Strait Islander organisations.

Career Development Grants for Individuals

Purpose: To fund a range of activities that benefit your career as an individual artist

Funding provider: Australia Council

If you are an individual artist, arts worker or group of artists, a Career Development Grant can provide support to further develop your skills or improve your capacity to build an enduring career in the arts. Career Development grants are available from \$5,000 to \$25,000. These grants can support a broad range of activities such as skills and professional

development, mentorships, showcases, residencies and other projects directly related to your career development. Supported activities must last no longer than two years from the proposed start date.

Contemporary Music Touring Program

Purpose: To support national touring activity undertaken by Australian musicians performing original contemporary music.

Funding provider: Australia Council

Amount: up to \$15,000

Closing date: Tuesday 5 February for projects starting after 1 May 2019. Or Tuesday 1 October for projects starting after 1 January 2020.

This program provides travel support of up to \$15,000 for artists and their manager for tours in Australia that include performances in regional and remote areas.

Who can apply:

Funding on a tour by tour basis is available to enable professional musicians to tour live music performances within Australia. Touring musicians must be performing original Australian contemporary music. Funding can be provided to performers, managers, agents, and music networks on behalf of professionals working in the Australian music industry.

What can be applied for:

Applications must contain one tour only. The tour must comprise of performances in at least three venues outside of the performer's hometown and must include at least one performance in a non-metropolitan area. Tours that include a majority of regional destinations or assist performers from regional areas are a priority for funding.

Purpose: Develop Arts and non-arts partnerships that will enable future projects

Amount: Up to \$5,000

Funding Provider: The Australia Council
Closing Date: Ongoing Fund

This initiative provides seed funding to support the development of arts and non-arts partnerships that will enable future projects. Individuals, groups and organisations can apply. Partnership Development offers support of up to \$5,000 to undertake further development and/or extension of effective partnerships. Applicants need to carefully consider the scale and complexity of the partnership development when considering if the activity warrants going through a Partnership Development grant process.

Community Partnerships supports a number of priority areas that cover a range of geographic, demographic and social contexts. These priority areas serve to focus effective use of the resources of Community Partnerships and include regional Australia, disability, young people, cultural diversity, emerging communities, Indigenous people, remote Indigenous communities, and specific critical social and cultural issues requiring focused attention.

Performer's Trust Foundation Grants

Purpose: Grants to promote and encourage music and the performing arts

Amount: Usually no more than \$2,500 for individuals and \$5,000 for groups

Funding Provider: Phonographic Performance Company of Australia (PPCA)

Closing Date: Ongoing

All applications for grants are reviewed by the trustees and must be for **one or more** of the following purposes:

- Performances at concerts at or for charitable institutions such as hospitals or homes for the aged;
- Scholarships for the promotion and encouragement of musical and theatrical education;
- The promotion and encouragement of the performing arts to the general public;

- The aid or assistance of any beneficiary who is unable to adequately maintain herself/himself by her/his own exertions and other income

A grant under the PPCA Performers' Trust Foundation can be used for costs associated with the above, including:

- Tuition fees;
- Travel costs (hire, airfares, petrol);
- Accommodation;
- Venue hire/ PA hire

A grant cannot be used to cover wages, salaries, commissions etc.

If you pay for more than 50% of the cost for an item, you can choose to take ownership, rather than having a permanent loan. However, this means that you are responsible for all repairs to that item.

Purpose: To assist low-income Queenslanders who have specific medical conditions to meet the electricity costs they incur through frequent operation of an air-condition to regulate their body temperature
